

# Modeling Lifetime Value in the Insurance Indutry

C. Olivia Parr Rud, OLIVIA Group

Acquisition modeling for direct mail insurance has the unique challenge of targeting responsive customers while minimizing risk. In addition, factors such as the probability of a paid premium and customer profitability all effect the Lifetime Value of a prospect. This presentation will detail the steps to develop a Lifetime Value, which can be used to optimize the selection of prospects. Topics covered include how to structure and prepare data for analysis to model construction and validation. Additional directions for overlaying a risk segmentation model and product profitability are described. A final discussion will cover criteria for final name selection based on company objectives.



Olivia has over 22 years experience in marketing industry with a 12-year emphasis in data mining, modelling and segmentation for a variety of industries. # Long Filename Extension vs Short Filename Extension

Alice Cheng, Merck & Co., Inc.

SAS Version 8, under Windows XP and NT environment with NTFS system, can create long (8-character) and short (3-character) filename extensions. The difference is more than just a naming convention of a filename. Unless clearly specified, SAS may only read one type of file extension. In this presentation, the presenter will discuss the following topics:

- Examples of Long and Short Filename Extensions
- Default SAS Engines
- Default File Extensions
- Control Over the Types of Files to be Input and Output

Examples will be provided as part of the presentation.

Alice Cheng is a Lead Statistical Analyst in Biostatistics Department, Merck & Co., Inc. She has over 10 years of SAS programming experience and has worked in health care, CRO and pharmaceutical industries. Alice has a MS degree in Statistics from Iowa State University.

Alice presented at MWSUG, PharmaSUG and NESUG. She was awarded the Best Paper Award for her PharmaSUG ('98) paper and an Honarable Mention award for her NESUG ('99) paper.

#### SAS v9: What's new in ODS and beyond Brian Schellenberger, SAS Institute

Brian will discuss what is new in SAS v9. He will give a quick overview of the broad sweep of features for SAS in v9, but will devote the bulk of time to his area of specialization, namely, new ODS features for v9. (We plan to have an expanded abstract posted to the PhilaSUG web site just as soon as we receive it from SAS)

Brian Schellenberger has been a developer at SAS Institute since 1984. He joined the company to help with the initial efforts for what was then known as "PC SAS" and did the initial v6 for procs PLOT, PRINT, STANDARD, TRANSPOSE, and RANK. He spent many years thereafter working on experimental and internal-support projects but eventually returned to his roots in base SAS to join the ODS project in order to be in charge of the ODS PRINTER destination.

# An Animated Guide: Disk Space/CPU Usage for Common SAS Processes

Programmers always want to write efficient code that "uses resources (CPU / Disk / Human) Gently". Inefficient coding can cause jobs to use excessive resources and to terminate without completing. These situations (unintended termination - because of inadequate CPU speed or disk space) often forces programming attention on the need to conserve a specific computer resource. Writing efficient code requires understanding how SAS coding techniques use specific resources.

This presentation reviews how several common SAS process use CPU and disk resources. Hopefully, knowing details of SAS resource usage will help in selecting SAS techniques that allow programs to run to completion when resources are limited- and to run quickly in all cases. Processes covered are: sorting, indexing, formatting, \_IORC\_ merges, Key indexing, un-named and named pipes, Bitmapping and hashing.

Russ Lavery is a member of the executive committee and has used SAS for fifteen years. His experience includes using SAS for marketing, planning and operational projects in several industries. He is an independent contractor who specializes in using SAS and statistics to solve business problems.
